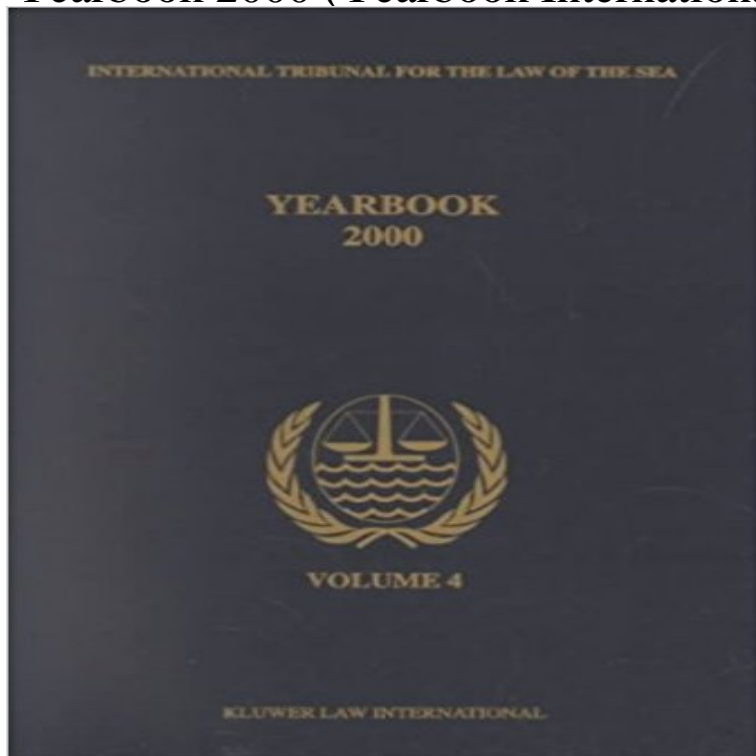


# Yearbook 2000 (Yearbook International Tribunal for the Law of the Sea)

The Tribunal has also published a volume of Basic Texts which contains documents that are fundamental to the mandate and operation of the Tribunal and which provides the essential documentation relating to the law and procedure applicable to the Tribunal. The Yearbook is also available in French (Annuaire).
