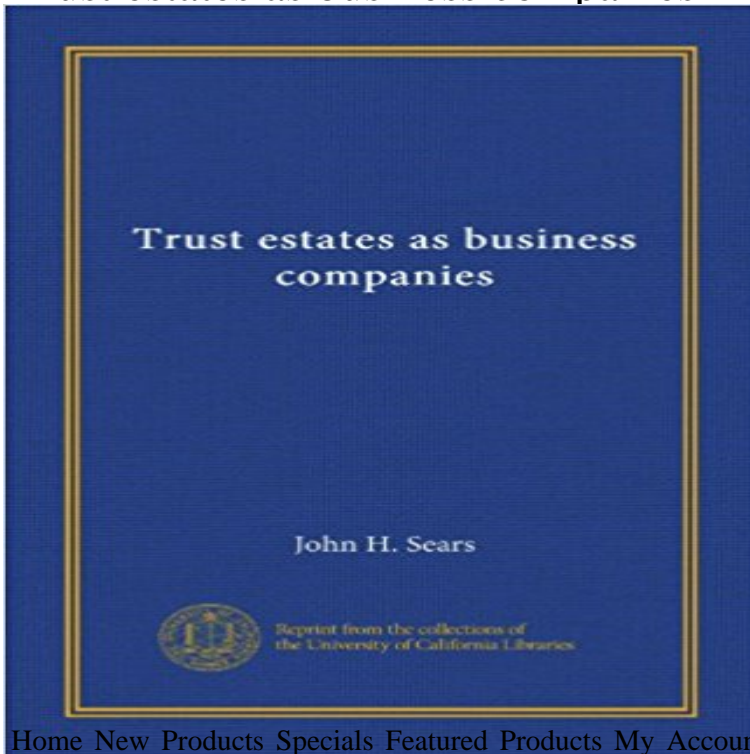


Trust estates as business companies
