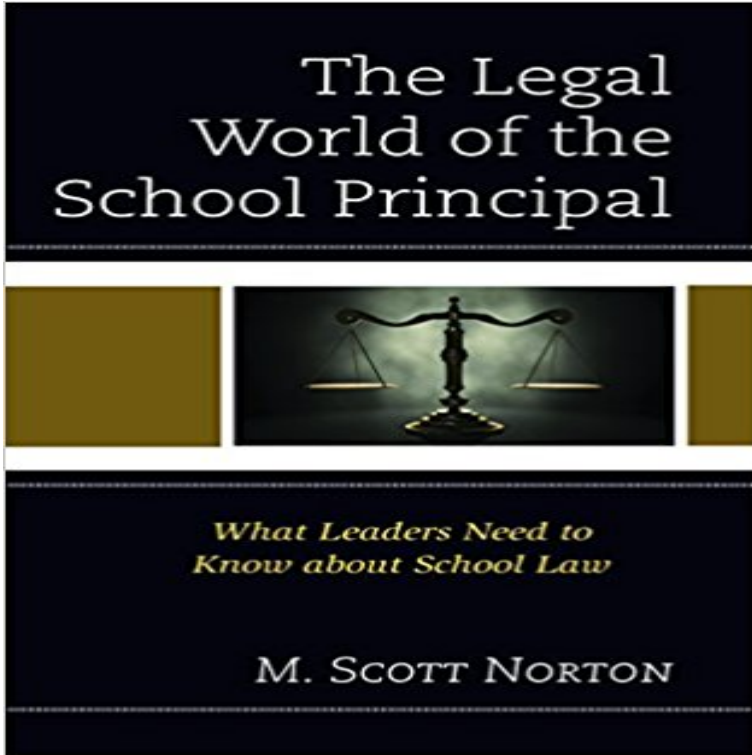


The Legal World of the School Principal: What Leaders Need to Know about School Law
