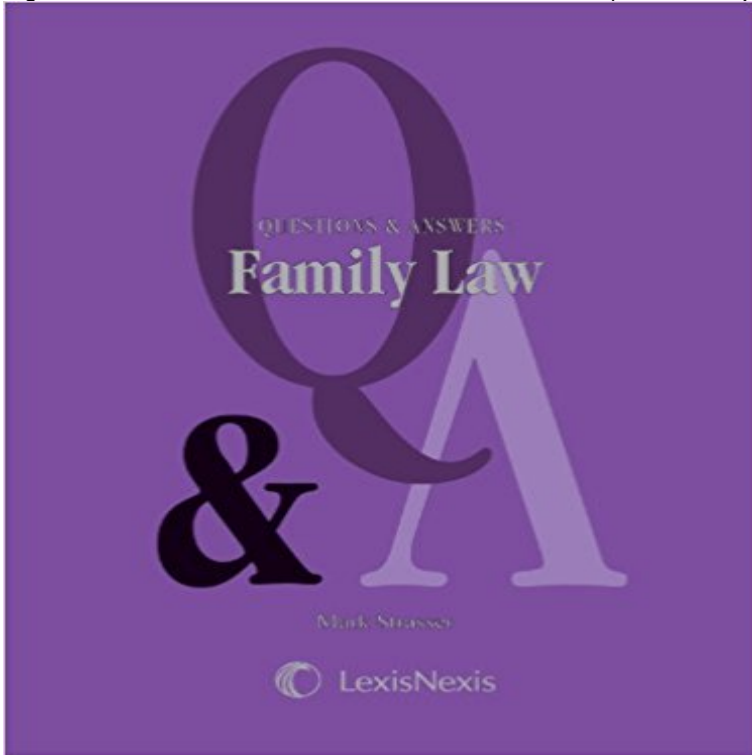


# Questions and Answers: Family Law (Questions & Answers)
