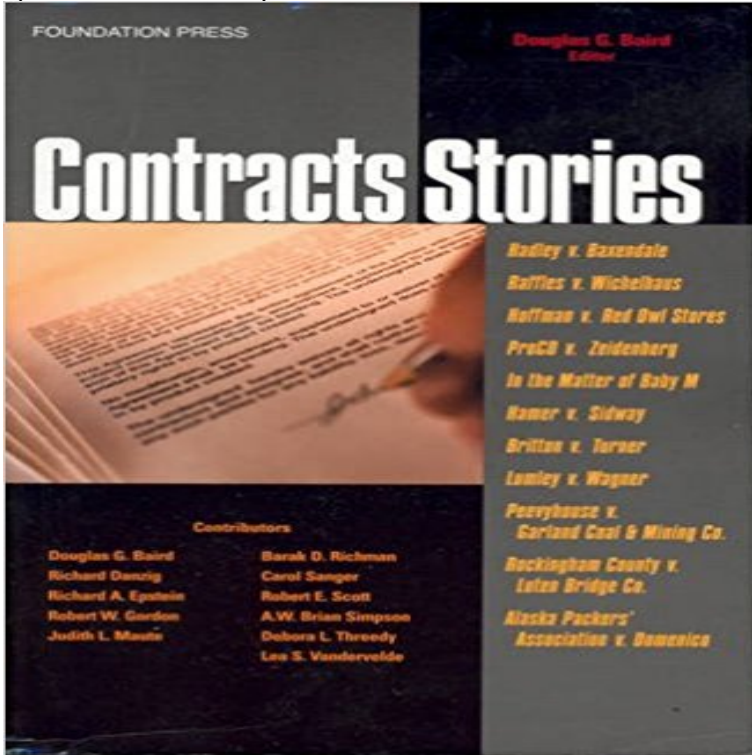


# Contracts Stories- An In-Depth Look at The Leading Contract Cases (Law Stories)
