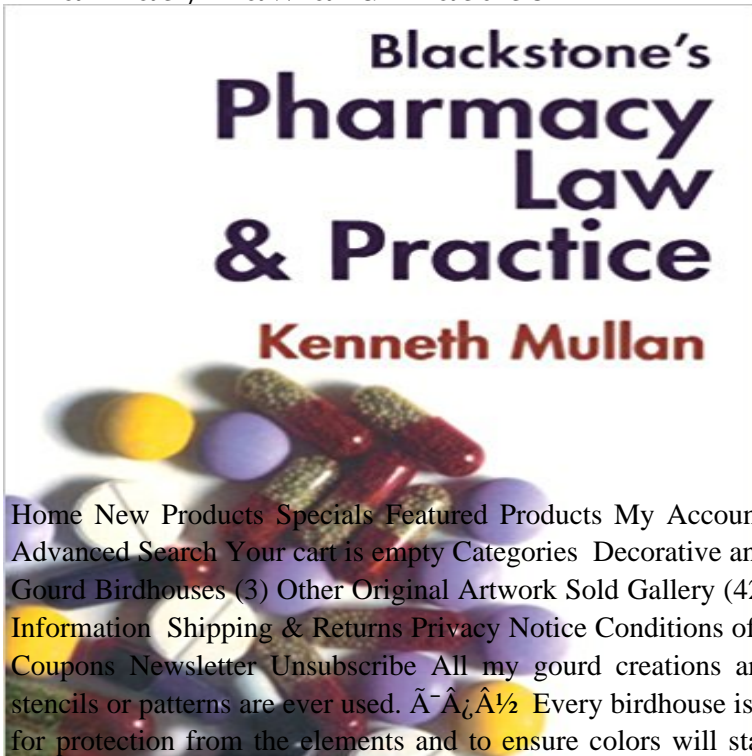


Pharmacy Law and Practice
