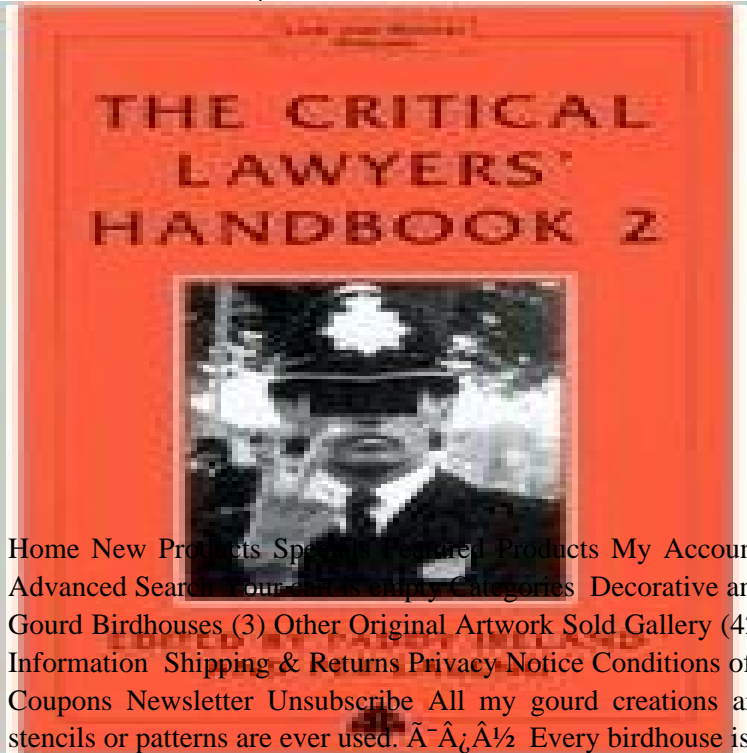


# Critical Lawyers Handbook Volume 2 (Law & Social Theory)
