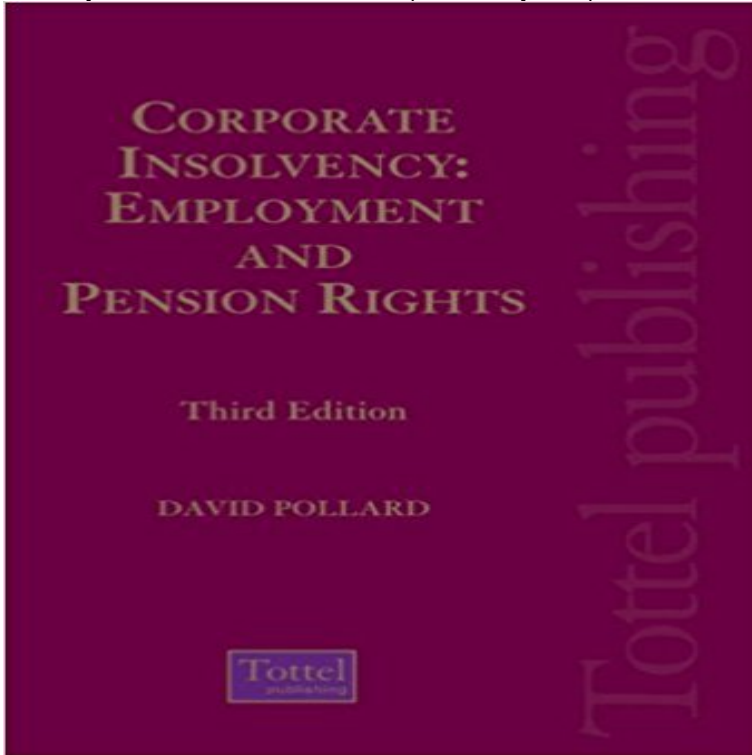


Corporate Insolvency: Employment and Pension Rights (Third Edition)
