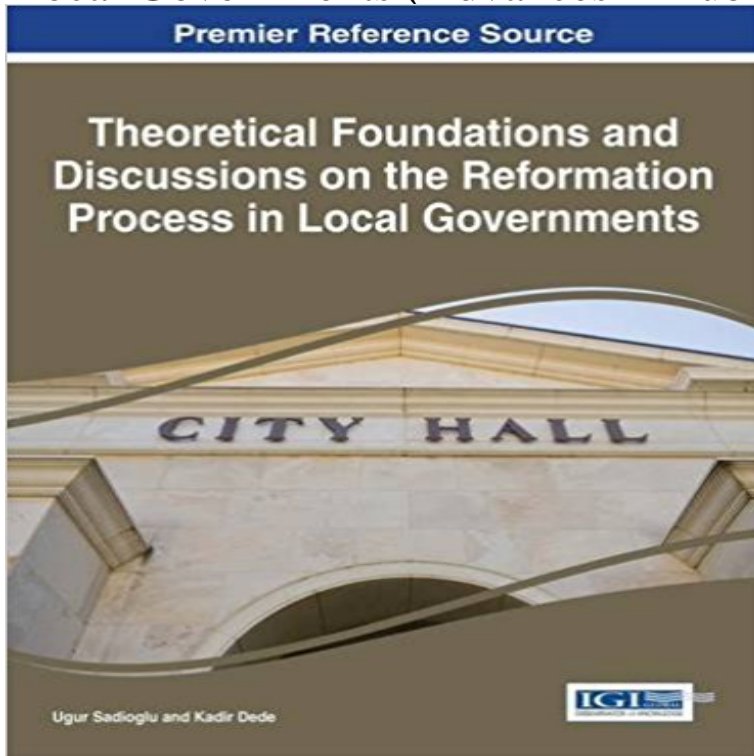


# Theoretical Foundations and Discussions on the Reformation Process in Local Governments (Advances in Public Policy and Administration)
