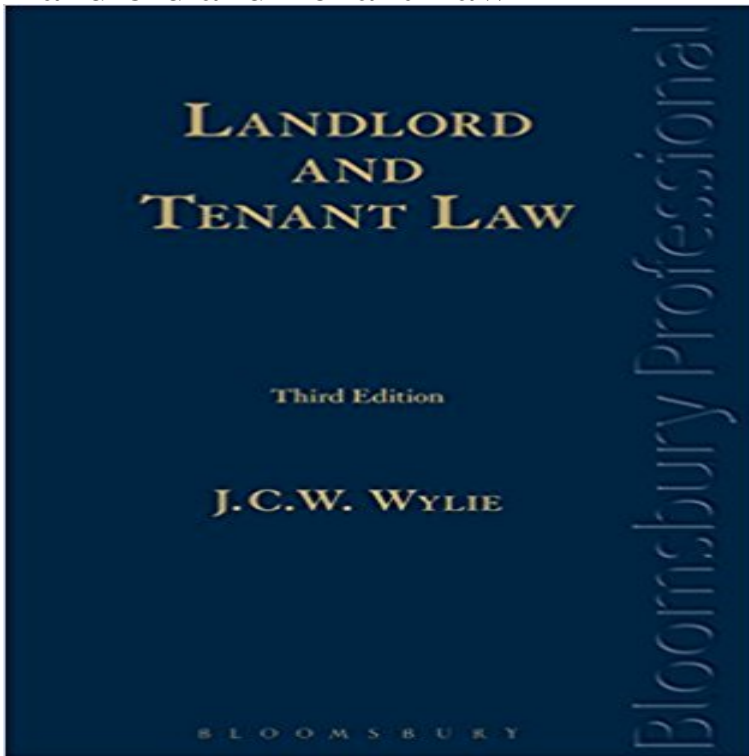


# Landlord and Tenant Law
