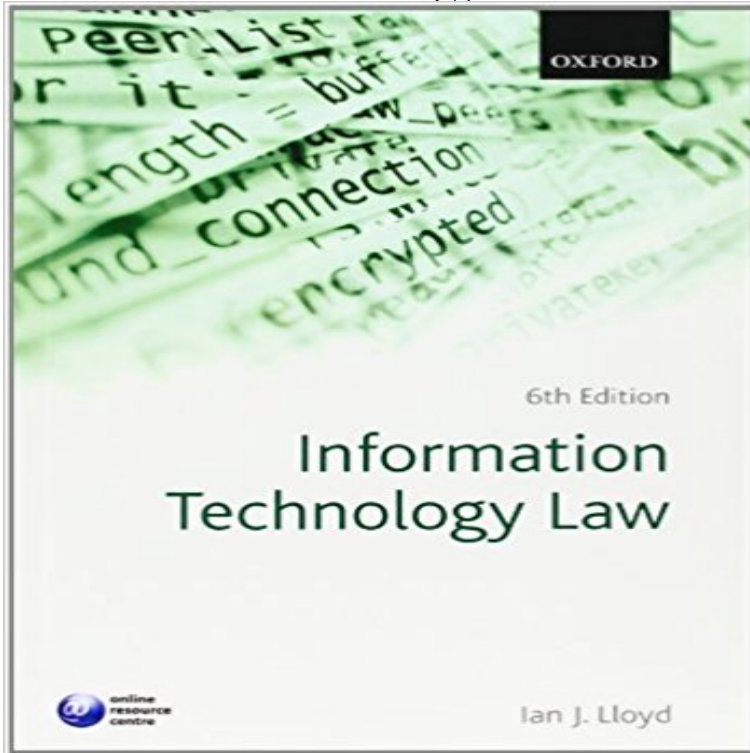


# Information Technology Law
