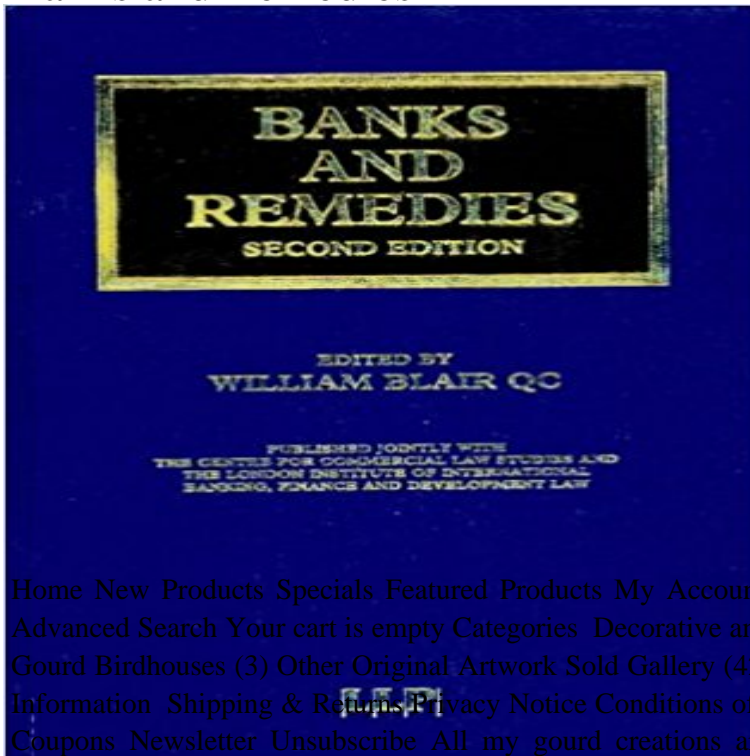


# Banks and Remedies
