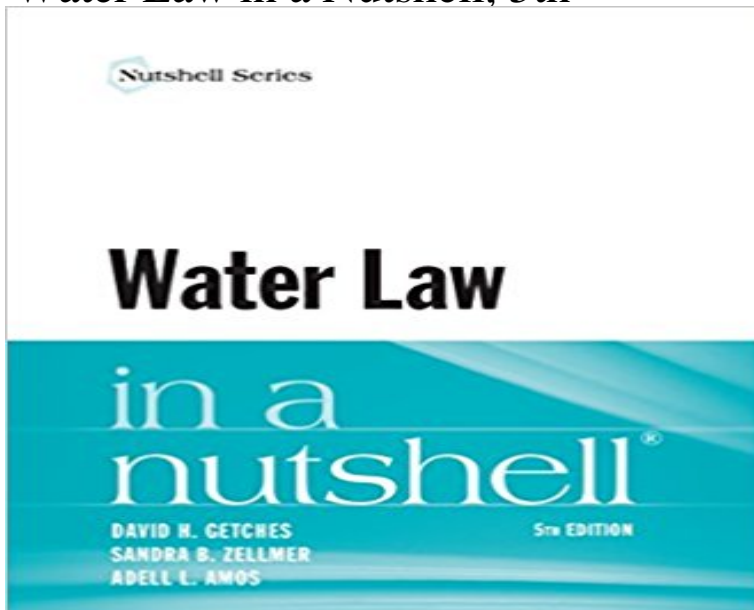


# Water Law in a Nutshell, 5th
