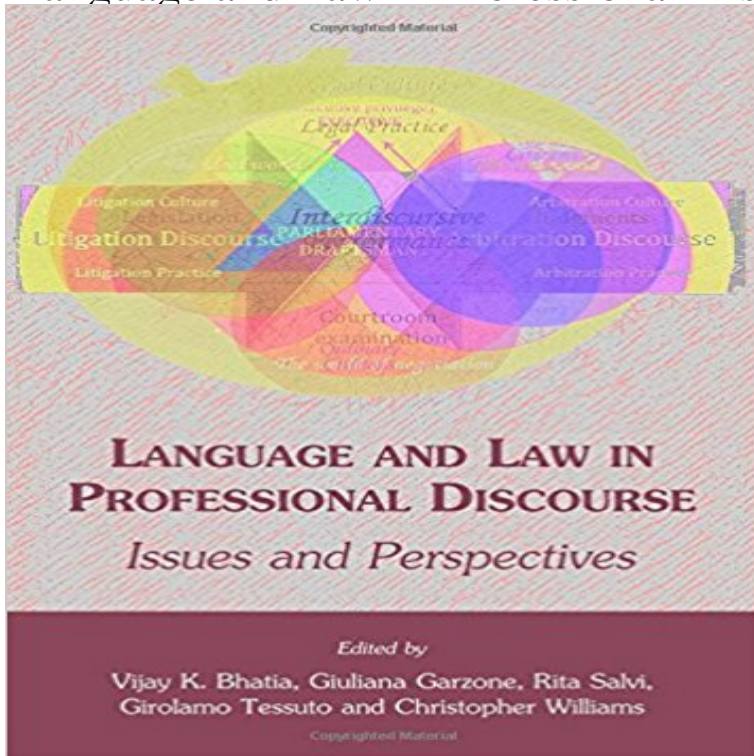


Language and Law in Professional Discourse: Issues and Perspectives
