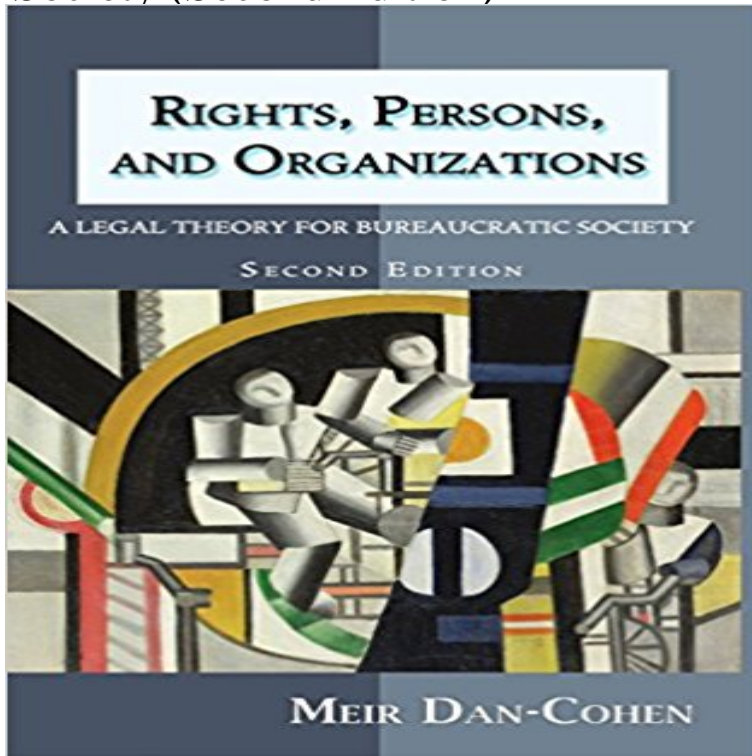


# Rights, Persons, and Organizations: A Legal Theory for Bureaucratic Society (Second Edition)

These are central questions for an organizational society such as ours, and yet they have received consistently little attention in modern political and legal thought. The surface metaphor of treating corporations as persons with rights carries profound consequences--sometimes even reducing individual freedoms in light of the organizations status. Especially after such recent Supreme Court decisions as *Citizens United*, this effect is as acute today as when this book was first written.
