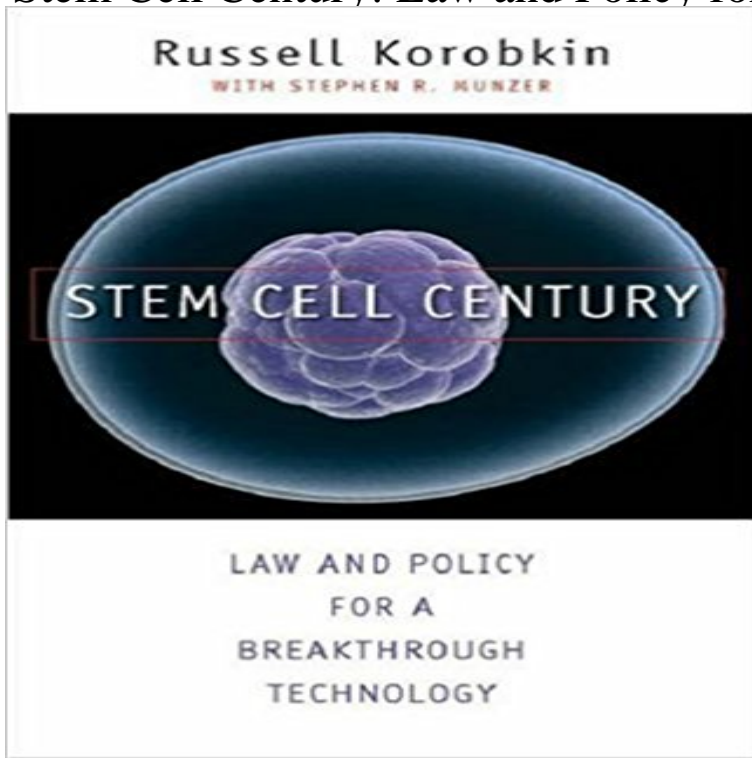


# Stem Cell Century: Law and Policy for a Breakthrough Technology
