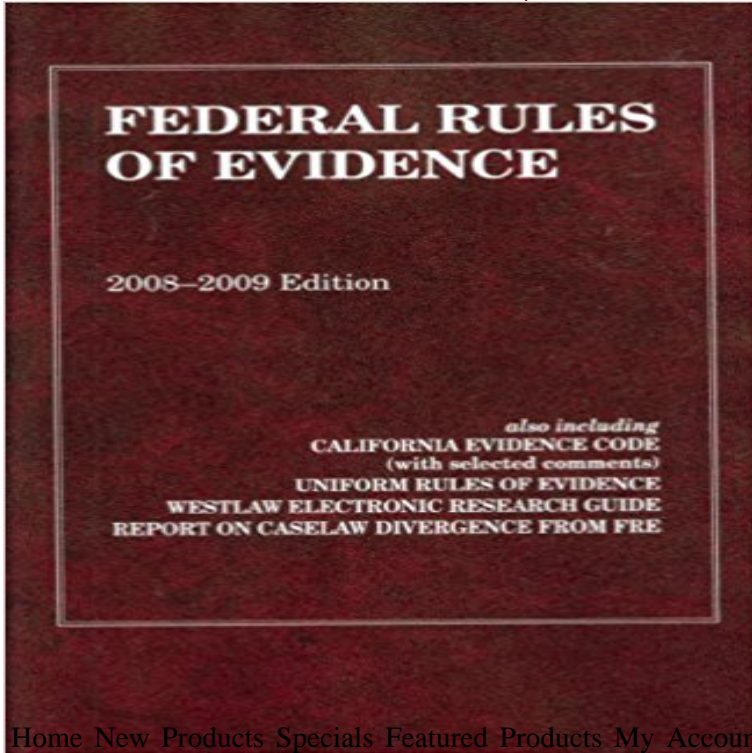


# Federal Rules of Evidence, with Evidence Map, 2008-2009 Edition
