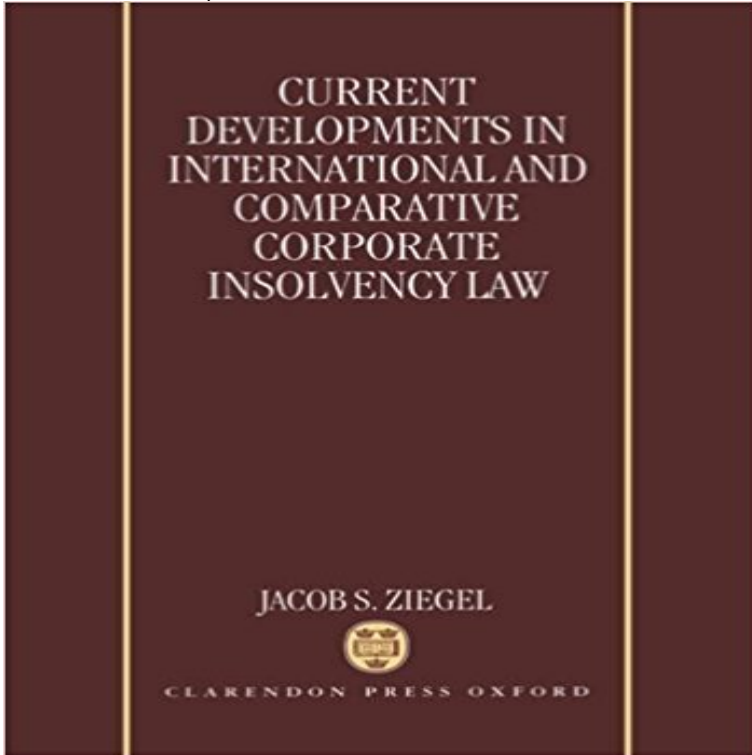


Current Developments in International and Comparative Corporate Insolvency Law
