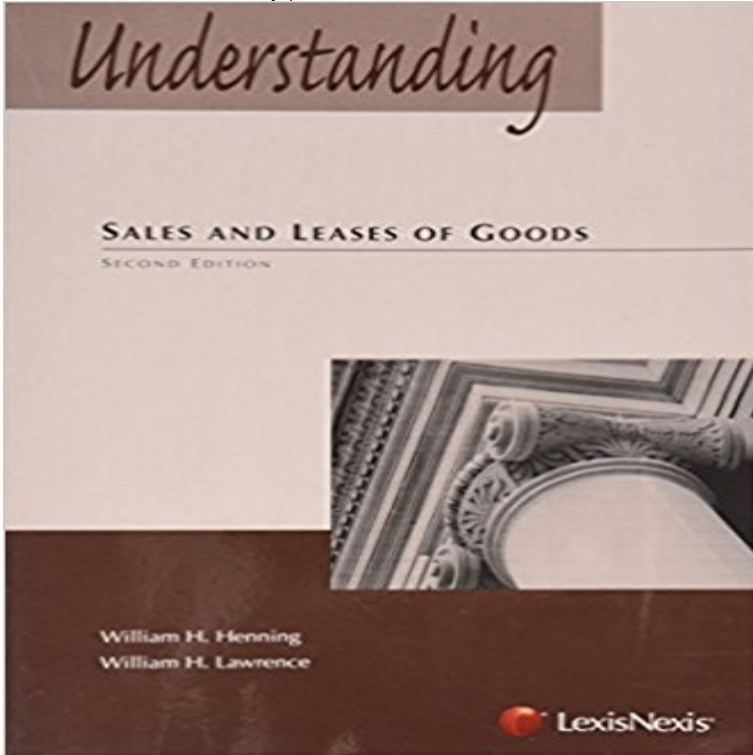


# Understanding Sales and Leases of Goods
