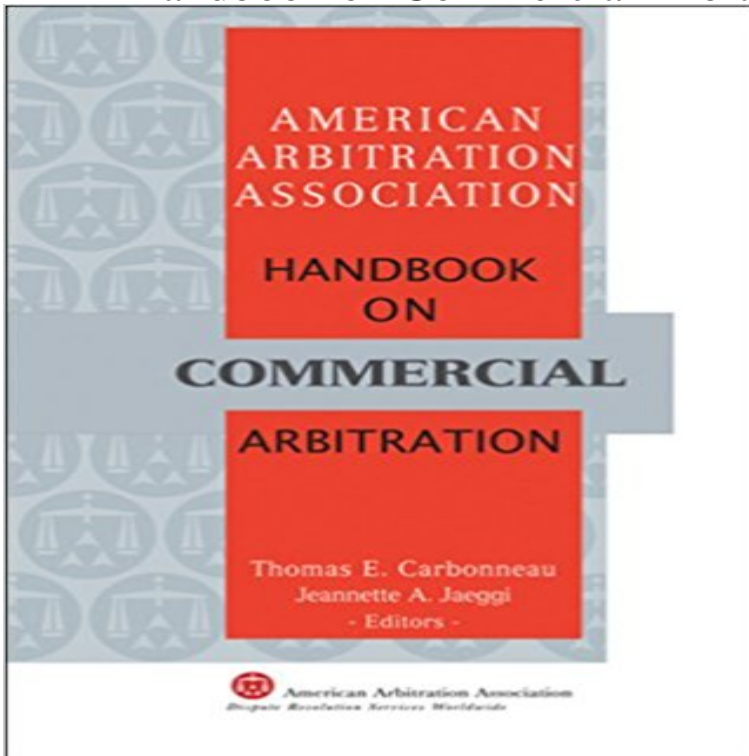


# AAA Handbook on Commercial Arbitration
