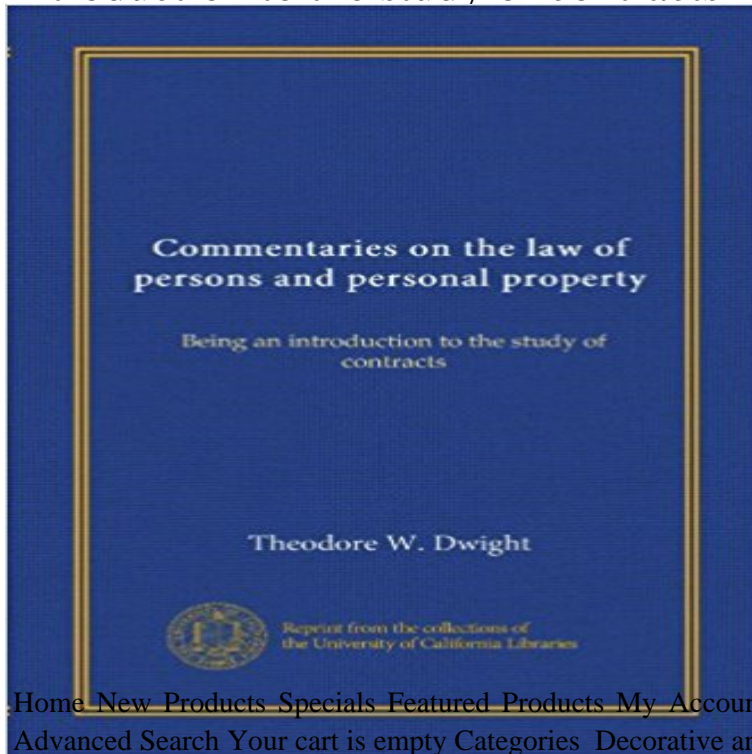


# Commentaries on the law of persons and personal property: Being an introduction to the study of contracts
