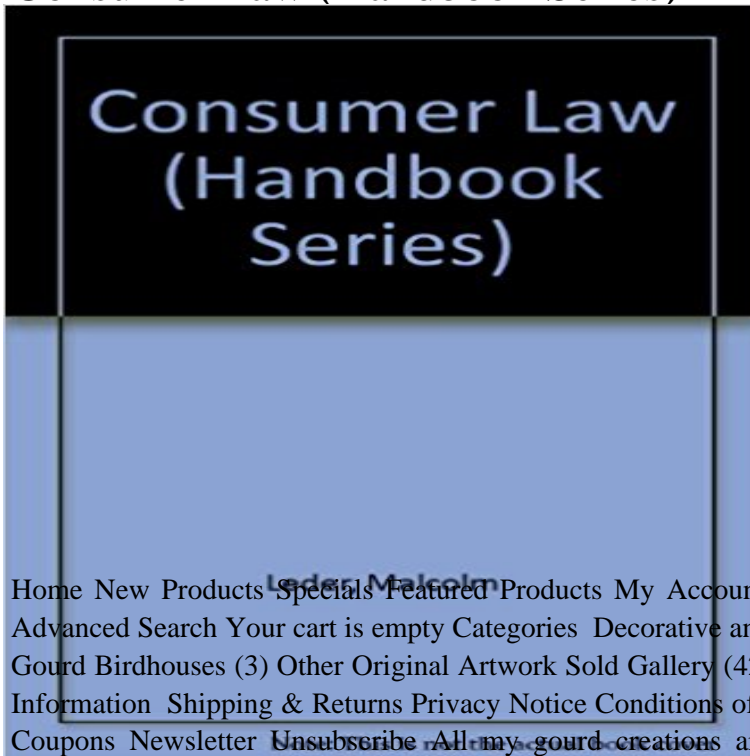


## Consumer Law (Handbook Series)
