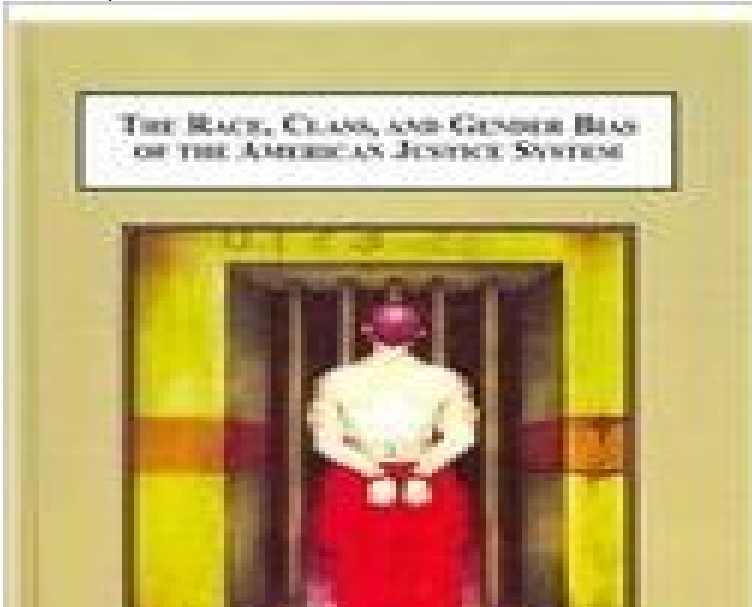


The Race, Class, and Gender Bias of the American Justice System: A Study of California's Three Strikes Law
