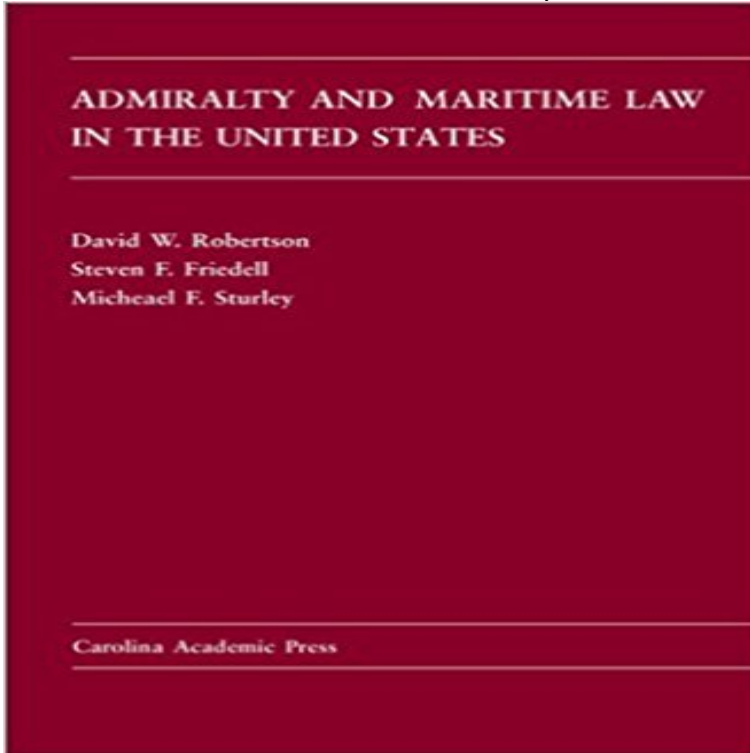


# Admiralty and Maritime Law in the United States (Carolina Academic Press Law Casebook Series)
