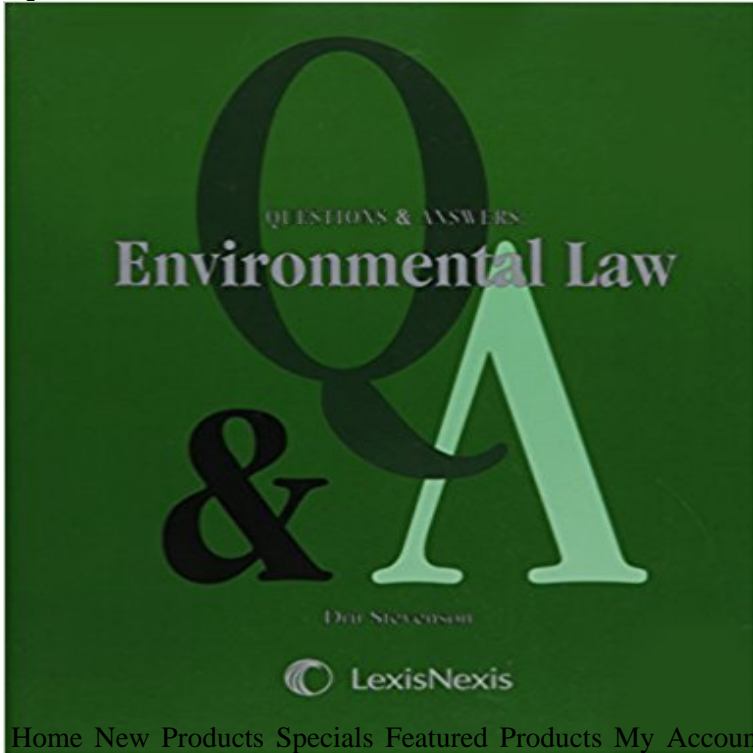


# Questions & Answers: Environmental Law
