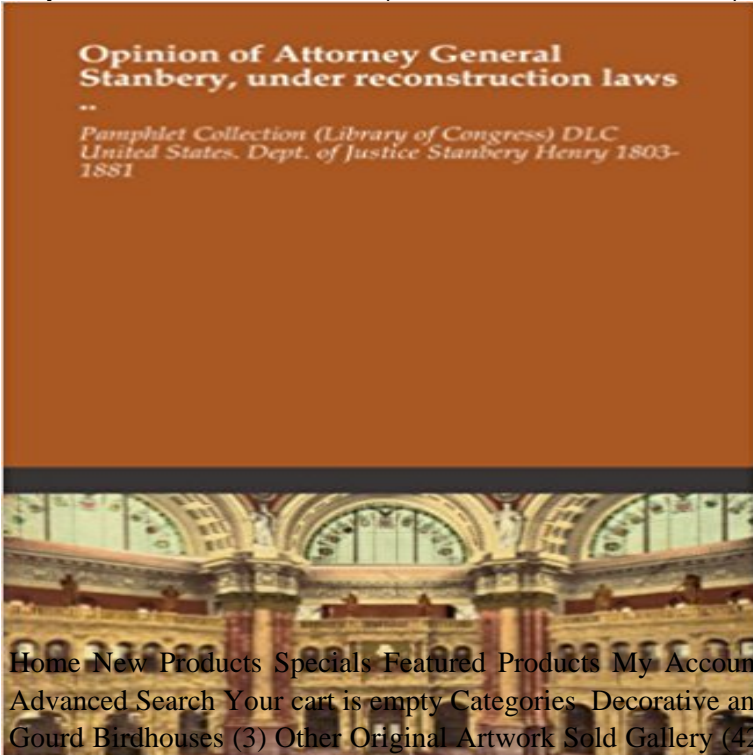


# Opinion of Attorney General Stanbery, under reconstruction laws ..
