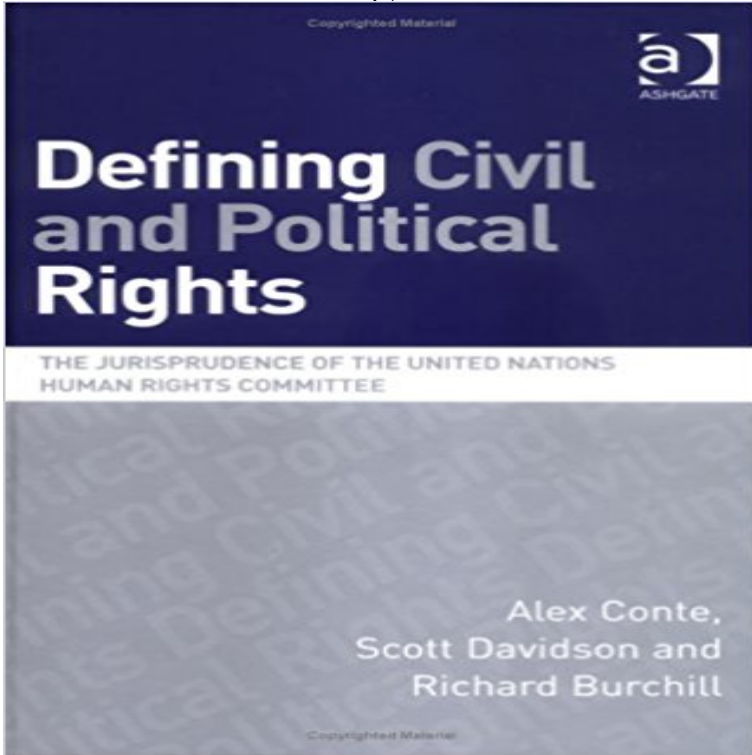


# Defining Civil and Political Rights: The Jurisprudence of the United Nations Human Rights Committee
