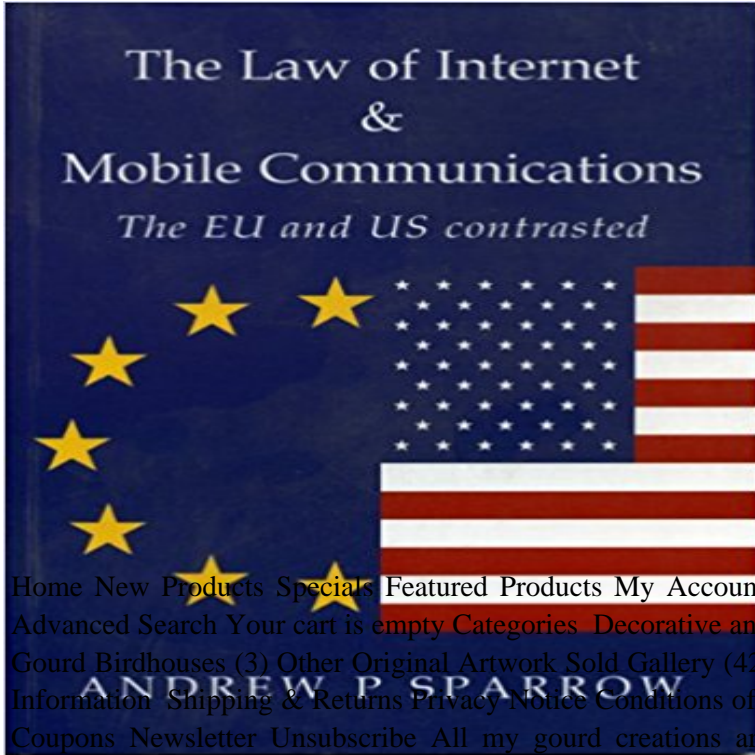


The Law of Internet and Mobile Communications - the EU and US contrasted
