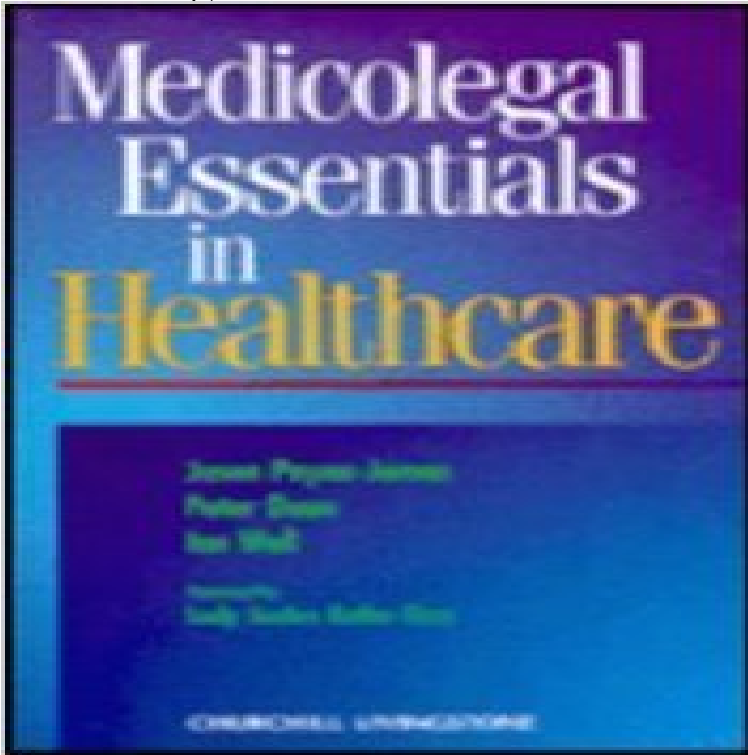


# Medicolegal Essentials in Healthcare
