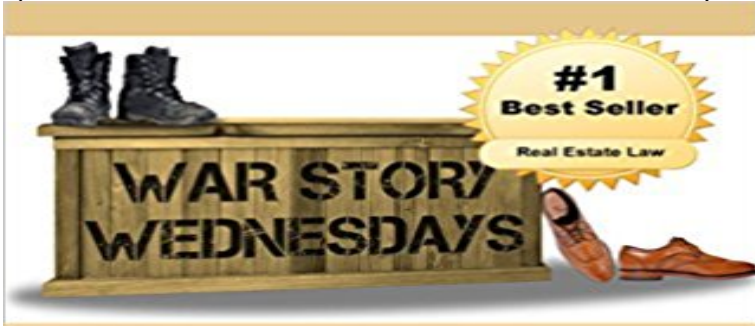


# War Story Wednesdays: A Trial Lawyers Tales from the Trenches (California Real Estate Law Book 1)
