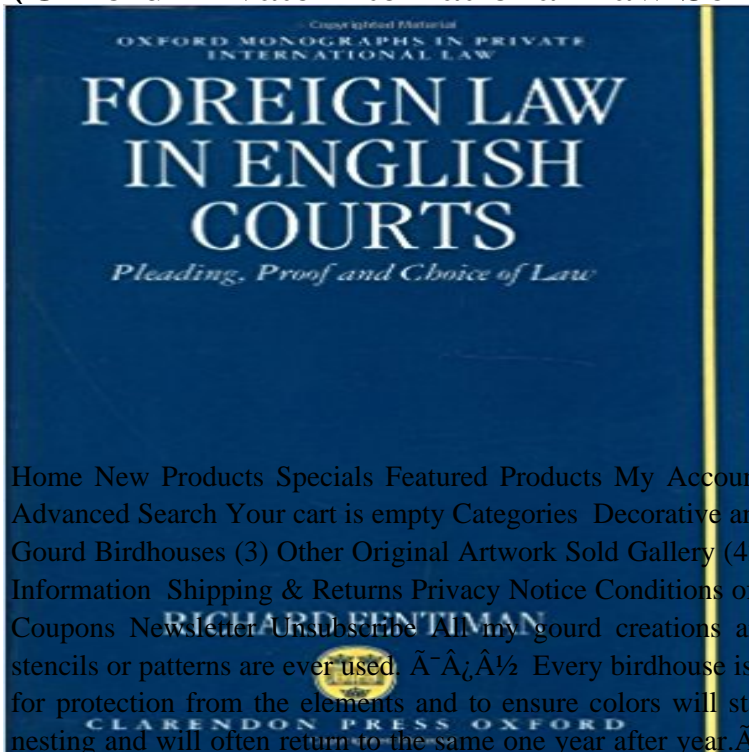


# Foreign Law in English Courts: Pleading, Proof and Choice of Law (Oxford Private International Law Series)
