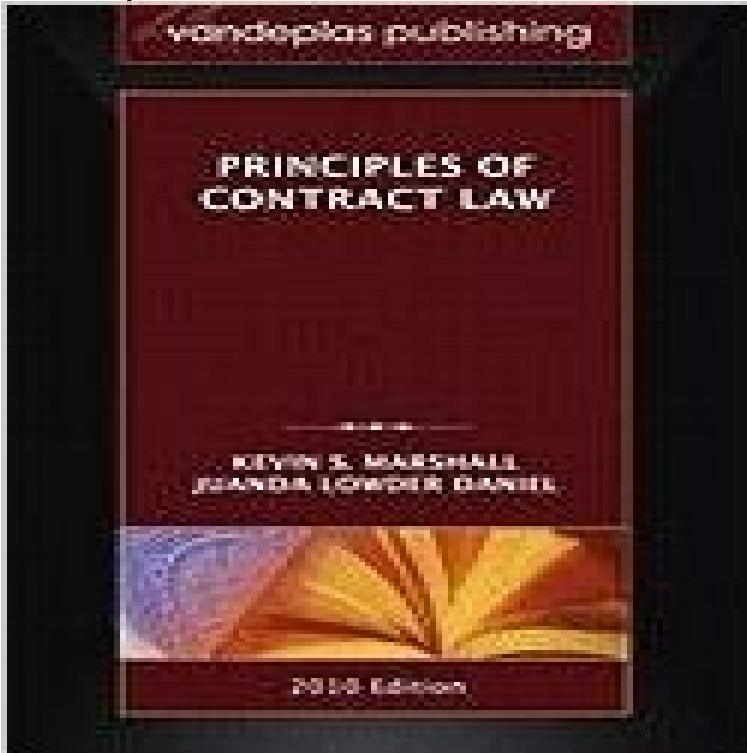


Principles of Contract Law - 2010 Edition
