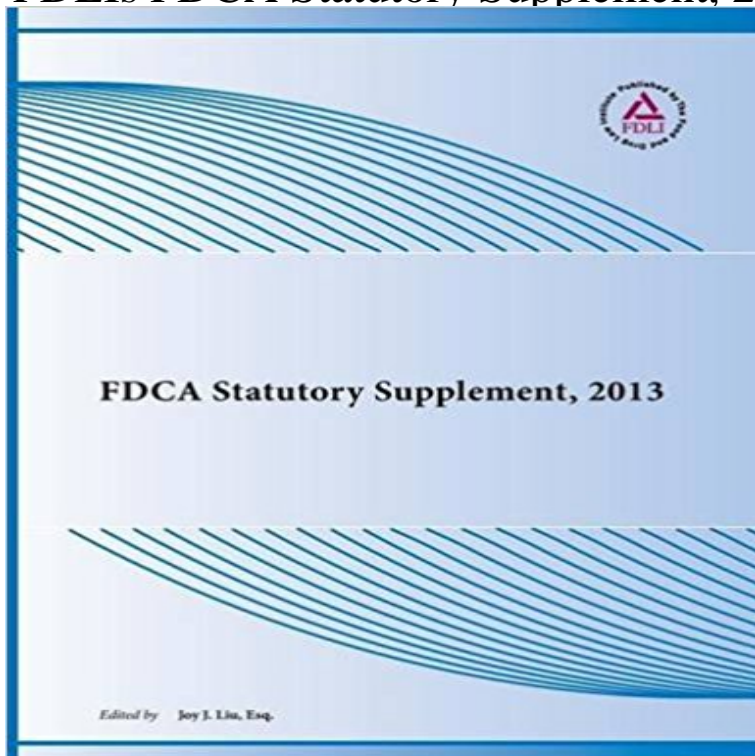


## FDLIs FDCA Statutory Supplement, 2013
