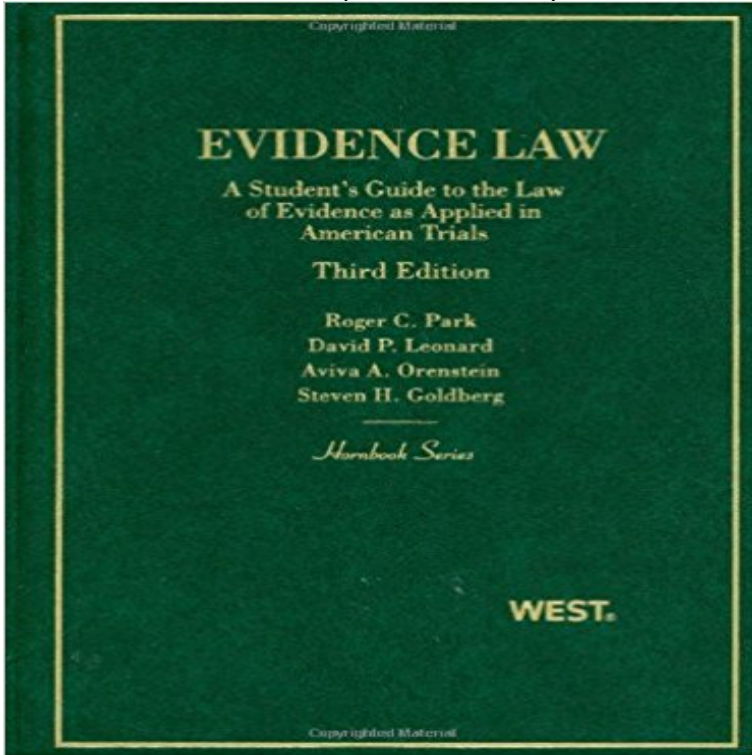


Evidence Law, A Students Guide to the Law of Evidence as Applied in American Trials (Hornbook)
