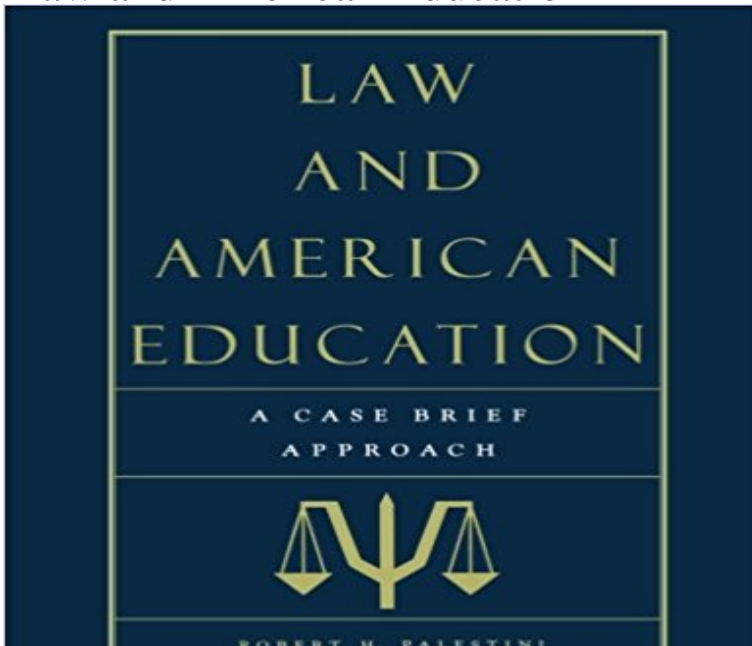


Law and American Education
