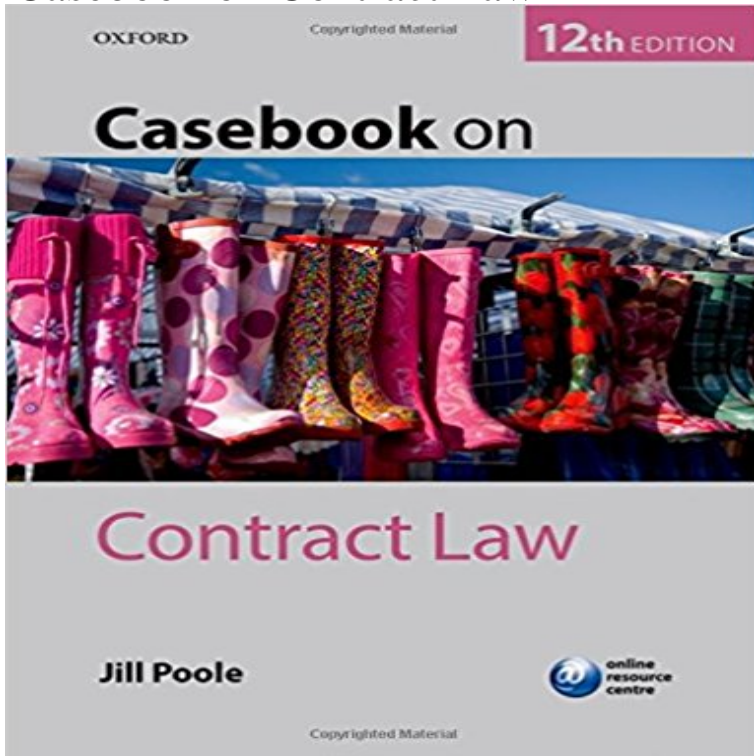


## Casebook on Contract Law
