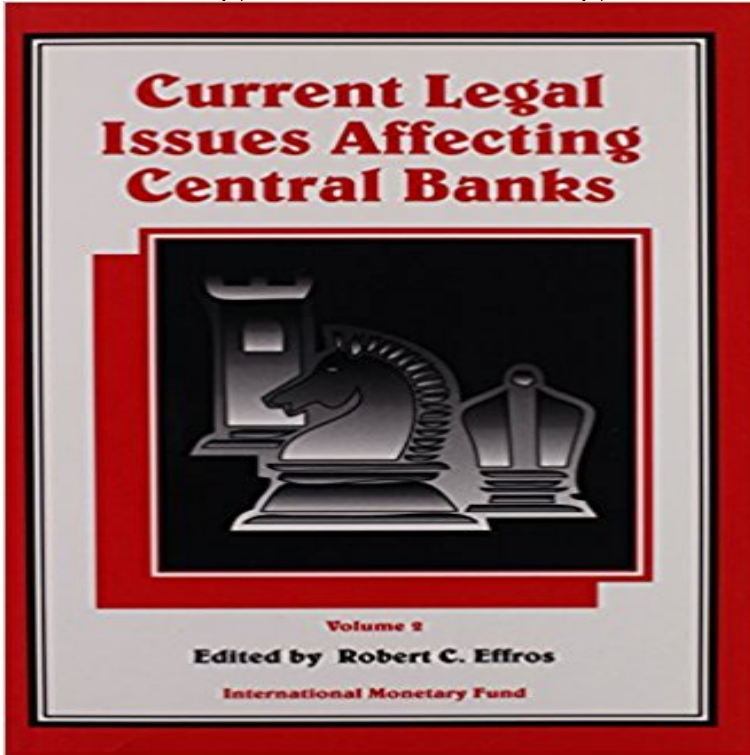


# Current Legal Issues Affecting Central Banks
