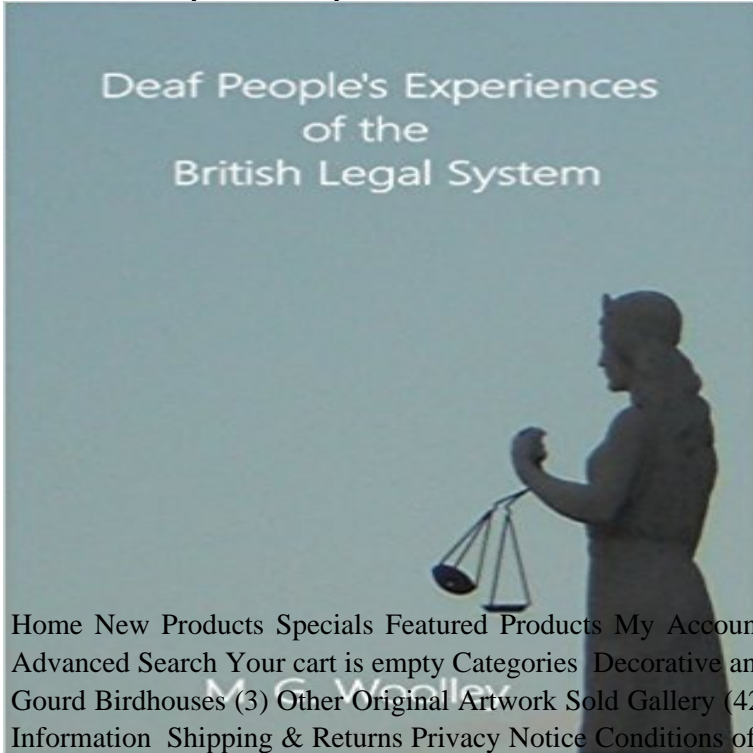


# Deaf Peoples Experiences of the British Legal System



A Masters thesis study from 2007, exploring the first-hand experiences of Deaf people as victims of crime in the British legal system and comparing them with those of hearing participants. The study also contrasts the experiences of Deaf people today with that of a Deaf man dealing with the legal system in the 1970s, exploring what has changed in terms of legislation, procedure and interpreting standards.
