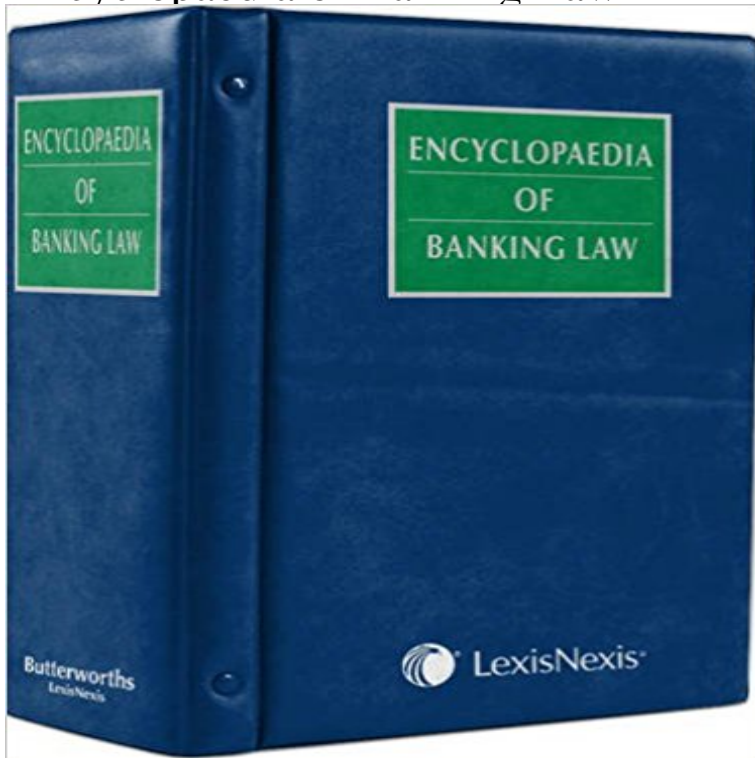


# Encyclopaedia of Banking Law
