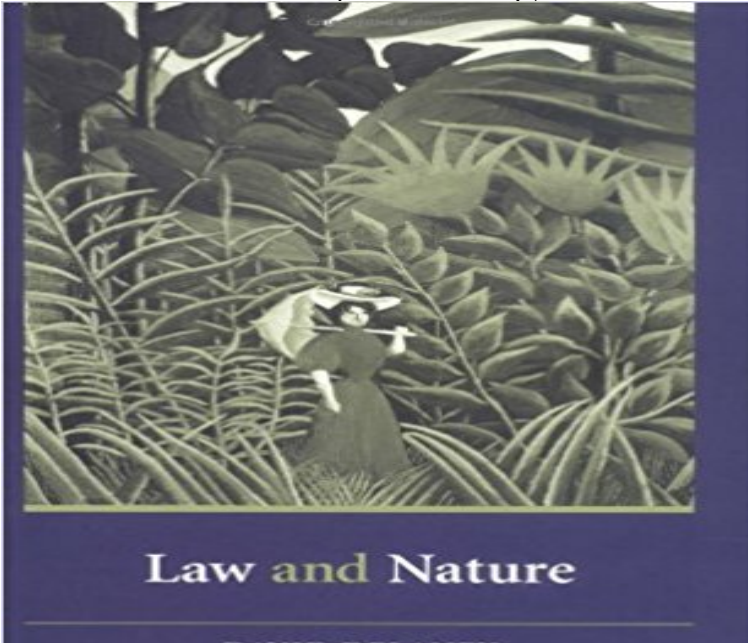


# Law and Nature (Cambridge Studies in Law and Society)
