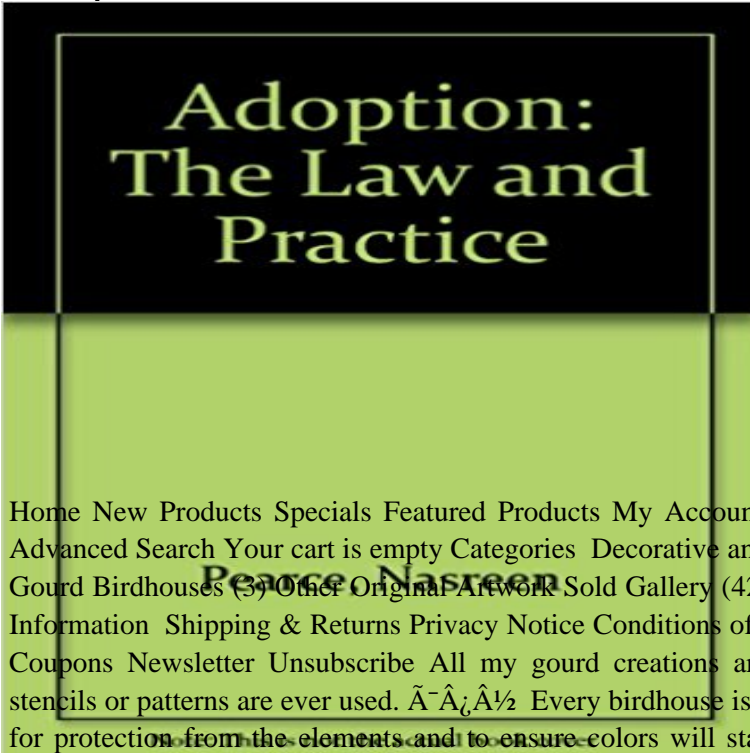


Adoption: The Law and Practice
