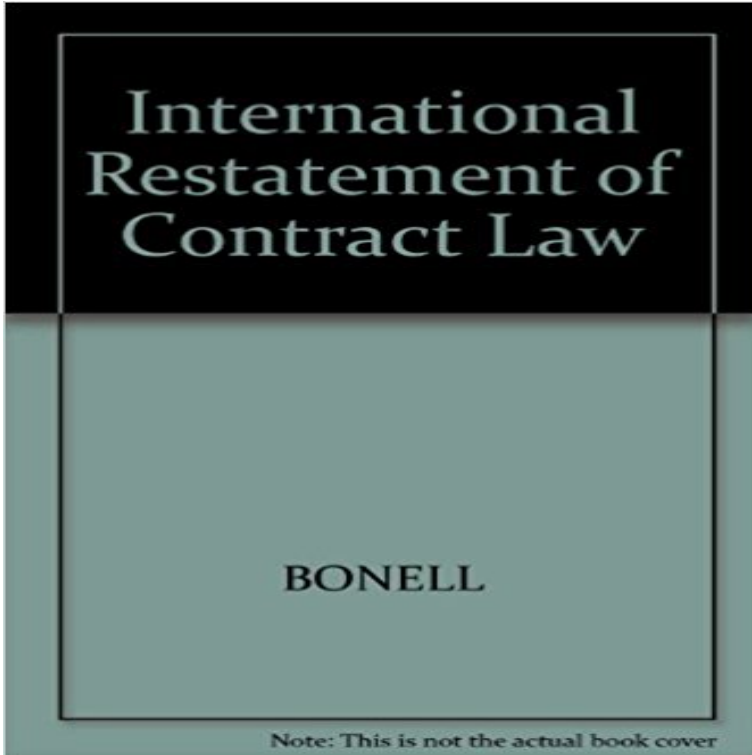


An International Restatement of Contract Law: The Unidroit Principles of International Commercial Contracts
