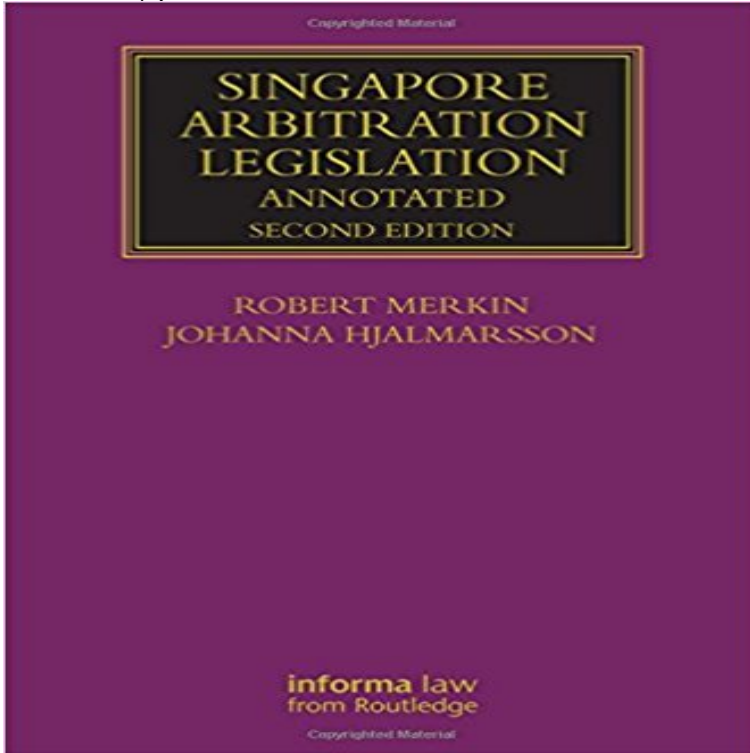


# Singapore Arbitration Legislation: Annotated (Lloyds Arbitration Law Library)
