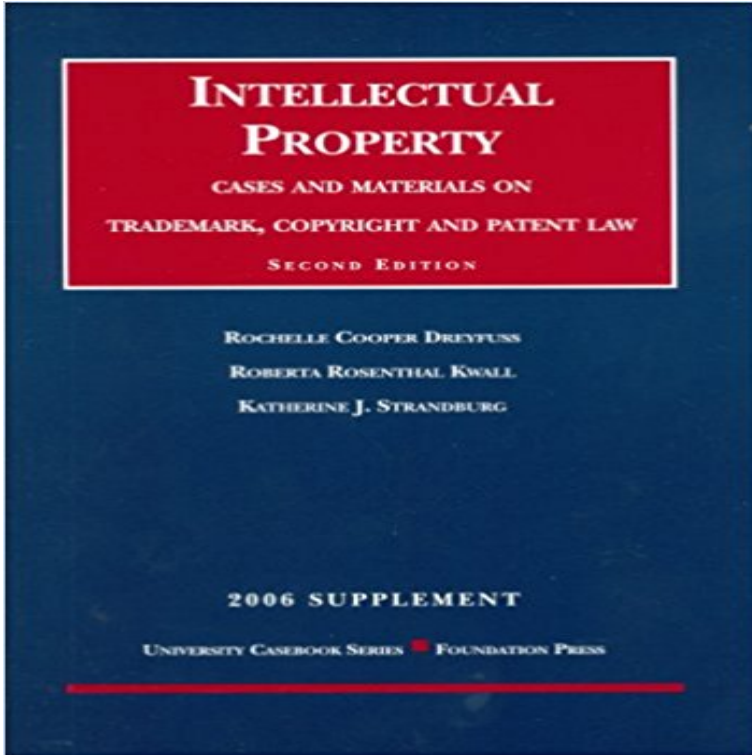


Intellectual Property Cases and Materials on Trademark, Copyright and Patent Law
