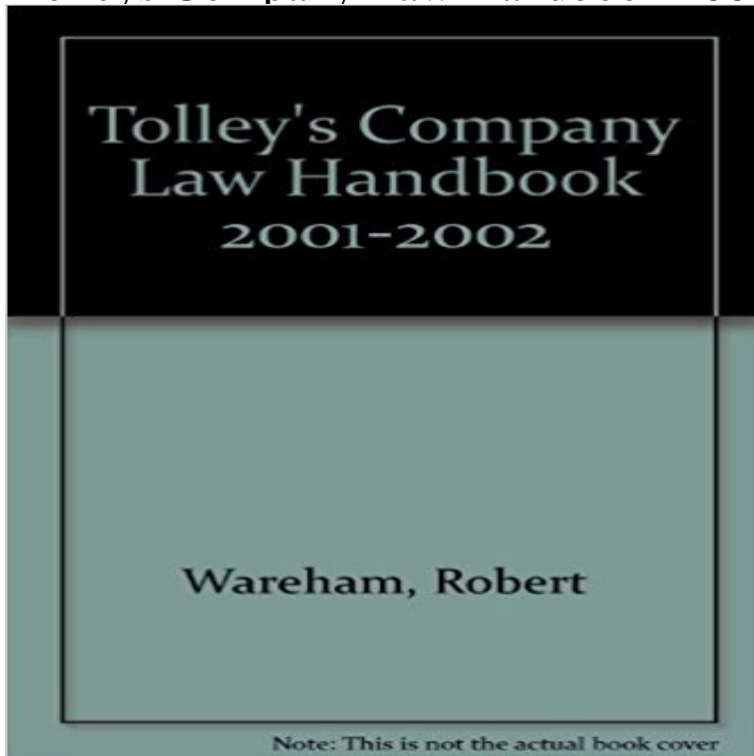


Tolleys Company Law Handbook 2001-2002
