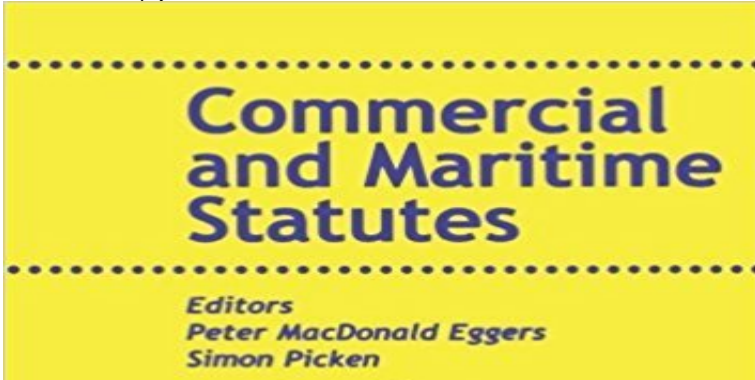


# Commercial and Maritime Statutes (Maritime and Transport Law Library)
