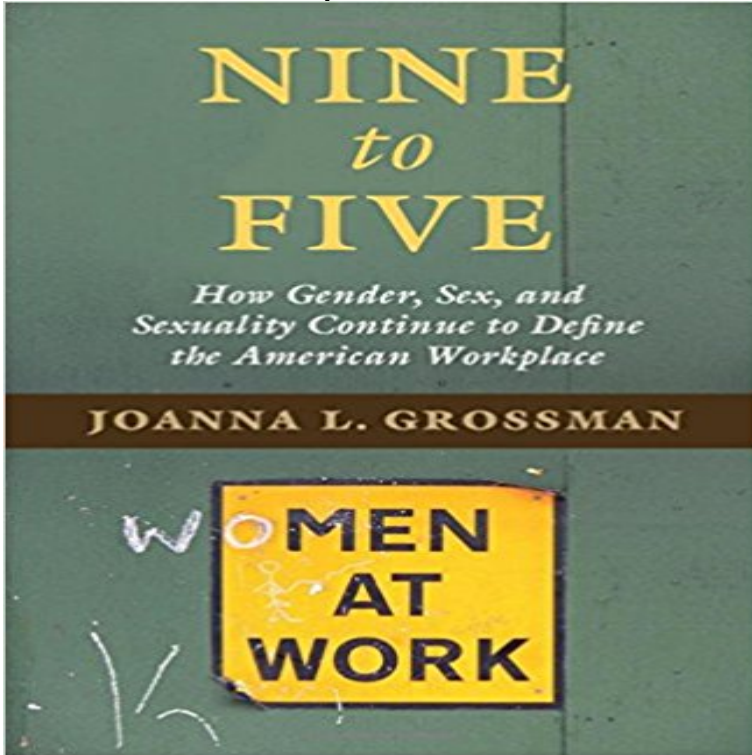


Nine to Five: How Gender, Sex, and Sexuality Continue to Define the American Workplace
