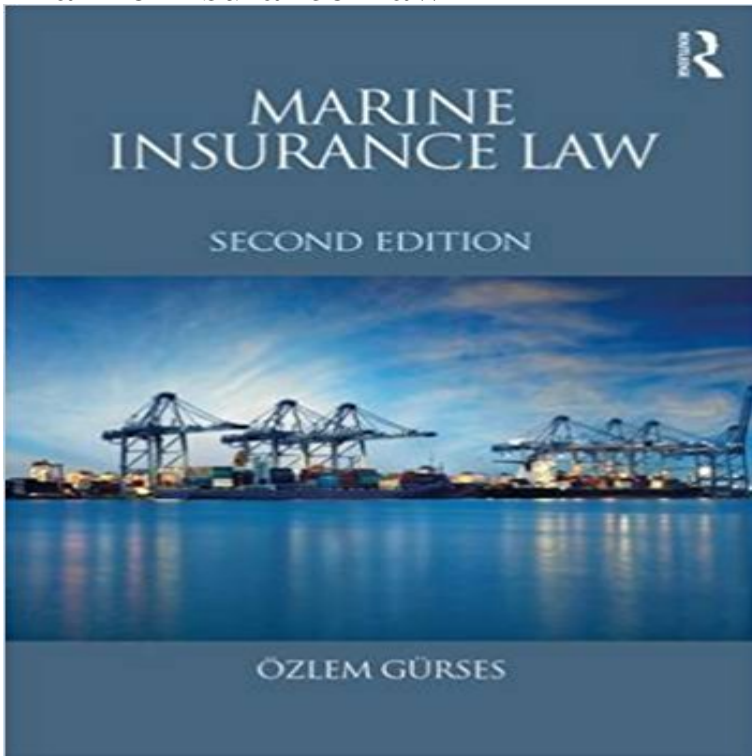


# Marine Insurance Law
