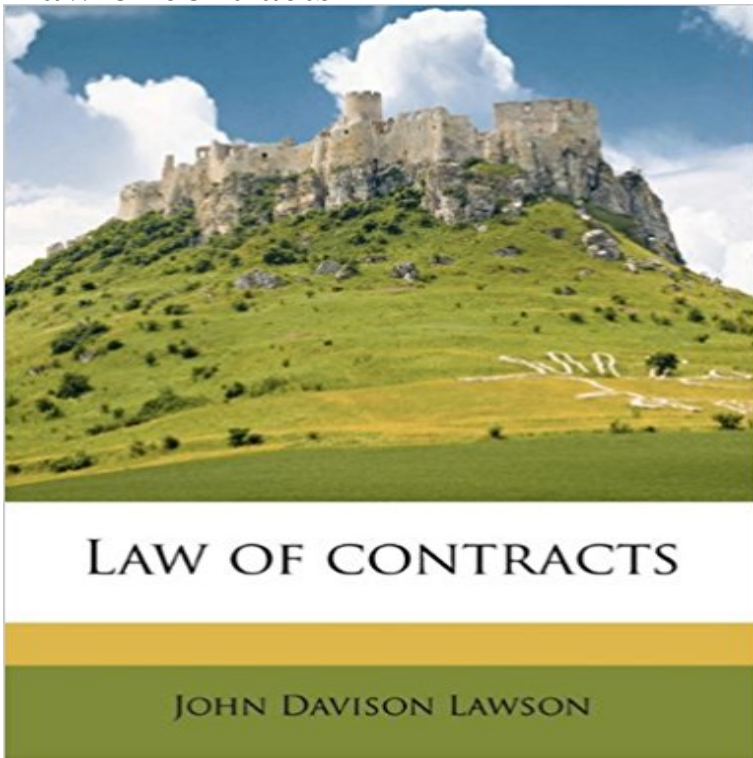


# Law of contracts
