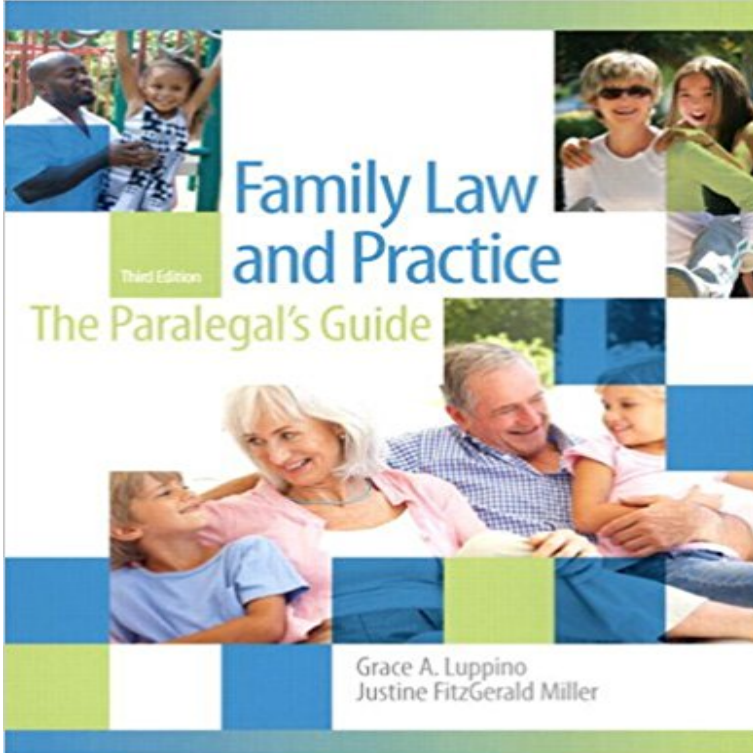


Family Law and Practice: The Paralegals Guide
